ACADEMIC PROGRAMS ENHANCED BY PRIVATE PHILANTHROPY

Over the course of this past academic year, a number of UC Santa Cruz programs have received a boost from private funding. Here are a few examples:

- ➤ Science, Technology, Engineering, Policy, and Society (**STEPS**) Institute for Innovation in Environmental Research received a \$500,000 commitment from alumnus Gordon Ringold and his wife, Tanya Zarucki. Directed by **Professor John Thompson**, the center will foster research on large-scale environmental problems facing our world today.
- ► Campus priorities of increasing graduate enrollments will be supported by the Bhojwani Family **Endowed Graduate Fellowship**. This \$200,000 commitment will fund an annual award to students who are the first in their family to attend graduate school.
- ▶ The campaign for **McHenry Library Expansion** is bolstered by a bequest of cash and securities totaling \$128,485. This is the first major gift to the Library Expansion project.
- ▶ **Alumni Reunion giving** has resulted in an all-time high in donations that will support many campus priorities. A total of \$647,460 was donated by this year's reunion classes.
- ▶ Private gifts have funded the **new University Center,** which will open during the next academic year. Looking out over redwoods, the center is being built on the third floor of the dining hall for Colleges Nine and Ten. This exciting venue promises to be a major asset to the campus and will provide a centrally located site for faculty to meet with colleagues, host professional meetings, and entertain guests in a very pleasant atmosphere.

A successful fundraising campaign to build the center has realized more than \$400,000 to date. With a donation or pledge of \$1,000, all faculty will have the opportunity to join as Charter Members and have their names engraved on a permanent plaque in the building.

FACULTY CONTRIBUTE TO ADVOCACY WITH GOVERNMENT OFFICIALS

In order to advance the goals of the university, the Government and Community Relations Office works closely with elected officials and their staff and facilitates the advocacy efforts of the campus. A more powerful influence results from this united effort, in which many faculty participate. Recent faculty engagement in advocacy activities coordinated by Government Relations includes the following:

- —**Professor Joel Ferguson**, Associate Dean, Jack Baskin School of Engineering, presented an overview of engineering achievements and plans for legislators and government staff in Sacramento.
- —**Assistant Professor Tara Madhyastha** attended the Alumni Associations of UC advocacy day in Sacramento and participated in legislative visits.
- —**Professor Patrick Mantey** and **Dean Sung-Mo (Steve) Kang** assisted in making legislative contacts to influence approval of the lease revenue bond that will benefit UCSC with funding for the Engineering Building and Institutes for Science and Innovation.
- Professor Gary Griggs, Professor Russell Flegal, Professor Carol Shennan, Professor Brent Haddad, Professor Manuel Ares, Professor John Vesecky, and Professor Patrick Mantey met on campus with U.S. Congressman Sam Farr to discuss science and research initiatives.
- **Professor Joseph Miller**, **Professor Gary Griggs**, **Professor Thorne Lay**, and **Professor Abraham Seiden** helped develop information to educate legislators on the importance of state investment in research specifically at UCO/Lick, the Institute of Marine Sciences, the Institute of Geophysics and Planetary Physics, and the Santa Cruz Institute for Particle Physics.
